## **Community Pitch voting draw – Terms and Conditions**

## 'Terms and Conditions':

- c. Entrants who have voted for their favourite community pitch idea will automatically be entered into a random draw.
- d. You can only enter and vote once.
- 6. Prizes will be drawn on **Monday 2 May**, **11am** at the **Altona Civic Centre**. The winners will be contacted via email.
- 7. By accepting a prize, you consent to having your first name displayed on the Promoters social media pages and website.
- 8. There are three prizes. Each prize is a \$50 voucher for a Hobsons Bay business of the winner's choice, one voucher per winner.
