SPOTSWOOD HERITAGE AMENDMENT C137 – FACT SHEET

Amendment C137 proposes to implement the findings of the Spotswood Heritage Review by introducing new and revised heritage overlays into the Hobsons Bay Planning Scheme.

THE SPOTSWOOD HERITAGE REVIEW

The Spotswood Heritage Review was prepared in March 2022 and identified additional properties of heritage significance to be protected by a heritage overlay within the Spotswood Activity Centre.

WHAT IS A HERITAGE OVERLAY?

A heritage overlay is a statutory tool in the planning scheme that seeks to protect and enhance places of heritage significance and ensure new development does not adversely affect the significance of the heritage place.

A planning permit for works and/or development is generally required for places in a heritage overlay. The planning permit process allows Council to assess how the proposed works will impact on the heritage significance of the place.

WHAT IS AMENDMENT C137?




Figure 1. Properties impacted by the amendment

Amendment C137 proposes to implement the findings of the Spotswood Activity Centre Structure Plan Heritage Review by introducing new and revised heritage overlays into the Hobsons Bay Planning Scheme. Properties impacted by the amendment are shown in Figure 1.

Specifically, the amendment seeks to:

- include 120 additional properties in the existing HO30 Spotswood Residential Heritage Precinct
- revise the existing HO46 AGM Factory Complex (former), now referred to as Melbourne Glass Bottle Works, and remove HO153 Hugh Lennon Agricultural Implement Works to accurately reflect the extent of historic built fabric at the site
- introduce six new heritage overlays:
 - » HO323 War Service Homes Commission Precinct
 - » HO324 Alloa Park Estate Precinct
 - » HO325 Australian Glass Manufacturers Housing Heritage Precinct

- » HO326 Spotswood State School
- » HO327 Shops at Hudsons Road
- » HO328 Baco Food Products Factory
- update the Schedule to Clause 43.01 Heritage Overlay to reflect the proposed heritage overlay changes identified above and to include the existing incorporated heritage guidelines in Clause 72.04
- amend planning overlay maps 4HO and 5HO to reflect new and revised heritage overlays identified above
- amend Schedule to Clause 72.04 (Incorporated Documents) to include Statements of Significance for new and revised heritage overlays
- amend Schedule to Clause 72.08 (Background Documents) to include reference to "Spotswood Activity Centre Structure Plan Heritage Review 2022"



If adopted by Council, the amendment will be submitted to the Minister for Planning. The Minister then decides whether the amendment is approved. Refer to Figure 2 for the process and timelines.
